Consultation Paper - Proposed Price Book 5.0

Overview

Vision Network is committed to providing a highly competitive value proposition for our broadband access products. We aim to challenge existing market pricing trends while simultaneously delivering enhanced value to both our partners and end customers.

To stimulate the residential market in response to the high demand for digital services, Vision Network seeks consultation on the following topics:

- Topic 1 Reduction of Spectrum Freedom and Spectrum Super Freedom Plans Charges
- Topic 2 Add 2Gbps speed plan HFC technology
- Topic 3 Fee adjustment 'Standard Install Fee' and 'Incorrect Callout Fee (includes no Fault found)'
- Topic 4 Price adjustment of NTUs (one-off pricing) OUBE & HFC Layer 3
- Topic 5 NNIs price adjustment across all technologies

Topic 1 - Reduction of Spectrum Freedom and Spectrum Super Freedom Plans Charges

Vision Network is exploring the option of reducing the monthly recurring fees associated with Spectrum Freedom and Spectrum Super Freedom Plans across various technologies such as FTTB, FTTH, FTTN, and HFC.

The proposed pricing and speed tiers for Spectrum Freedom and Spectrum Super Freedom Plans is set out in the Attachment to this Consultation Paper.

The proposed adjustments to pricing are anticipated to substantially enhance the value proposition of our broadband access products. This, in turn, is expected to bolster the number of subscribers opting for Vision Network's services, benefiting both our organisation and our valued customers – RSPs.

Detailed information on the pricing and speed tier for the Spectrum Freedom (Table 1) and Spectrum Super Freedom Plans (Table 2).

Subject to feedback, Vision Network anticipates Price Book (Version 5) coming into effect in mid of 2025.

Topic 2 – Introducing 2Gbps speed plan on HFC network

Vision Network is exploring an option to introduce 2Gbps/50Mbps speed plan on HFC technology. We aim to meet the growing demands of both end users and Retail Service Providers (RSPs). This high-speed plan offers unparalleled download speeds, enabling the opportunity for streaming, gaming, and large file transfers, while the robust upload speed supports efficient data sharing and cloud services.

Detailed information on the pricing and speed tier for the Spectrum Freedom plan (Data) – 2Gbps/50Mbps (Table 1) is provided in the attached consultation paper. We believe this new speed plan will significantly enhance an internet experience and support the digital needs more effectively to Australians.



Topic 3 – Fee adjustment 'Standard Install Fee' and 'Incorrect Callout Fee (includes no Fault found)'

Vision Network has an in-market promotional offer called "Spectrum Freedom Plan Free Install", which waives the standard installation fee for all new connections. This will help RSP and end-consumer to maximise the benefit and enable them to connect to Vision Network seamlessly without worrying to pay one-off install fee.

Vision Network is exploring an option to permanently waive the 'Standard Install Fee" only.

Additionally, Vision Network is evaluating adjustments to the 'Incorrect Callout Fee (includes No Fault Found)' to better align with business and market standards.

Detailed information on the pricing 'Standard Install Fee' (Table 1 & 2), and 'Other Charges' (Table 4).

Topic 4 - Price adjustment of NTUs (one-off pricing) - OUBE & HFC Layer 3

Vision Network is deploying NTUs for various technologies, including OUBE (reserve power) for VDSL and HFC (Layer 3) – Onebox solutions. Due to recent global inflation, we are evaluating adjustments to the one-off pricing of NTDs.

Detailed information on the pricing in the table of "Spectrum Freedom Plans" (Table 1)

Topic 5 - NNIs price adjustment across all technologies

Vision Network is looking to adjust NNI pricing, one-off activation and monthly recurring fees to align with market standards and comply with regulatory requirements. These changes will significantly enhance the simplicity and competitiveness of our product offerings. See Table 3 for proposed pricing.

Impact on current promotions

Vision Network is currently conducting the following promotions:

- 1. NNI RSP Connect Promotion 1 March 2023 31 March 2025
- 2. Spectrum Freedom Plan Free Install Promotion 1 March 2023 31 March 2025
- 3. Spectrum HyperSpeed 100Mbps Promotion 1 November 2023 31 March 2025
- 4. Spectrum 250Mbps Connect Promotion 1 October 2024 31 March 2025
- 5. Spectrum Max Speed Connect Promotion 1 October 2024 31 January 2025
- 6. Spectrum Go-Fast 50Mbps Promotion 24 June 2024 31 March 2025

Vision Networks intends for these promotions to continue until their planned end date.

Vision Network requests your feedback on the following:

- 1) Your view on the proposed pricing and speed offering across the Spectrum Freedom and Spectrum Super Freedom Plans?
- 2) What is the prevailing market trend regarding the adoption of higher speed plan? Is there a notable preference for high-speed tiers such as 2Gbps? Which types of customers would



- adopt these speeds? Is it the same customers as the current Max/50Mbps customers or is it a different segment?
- 3) What are your thoughts on the proposed adjustments to the 'Incorrect Callout Fee (includes No Fault Found)' while maintaining service quality?
- 4) What is your view on the permanent waiver of the 'Standard Install Fee'? What benefits or drawbacks do you foresee for both RSPs and end-consumers?
- 5) What is your view on the proposed adjustments to the one-off pricing of NTUs (OUBE for VDSL and HFC Layer 3)? What are the opportunities and benefits? Do you foresee any negative outcomes from the proposed adjustments?
- 6) What is your view on the proposed adjustments to NNI pricing, including one-off activation and monthly recurring fees? Will these adjustments help to ease any financial and/ or operational burdens? Are there any other potential effects?
